The 2021 membership dues quote listed on this invoice will be valid through March 1, 2021.

Tax Deductibility Notice. Dues payments, contributions or gifts to the Ohio State Bar Association (OSBA) are not tax deductible as charitable contributions for income purposes. However, they may be deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of OSBA lobbying activities. The OSBA estimates that the deductible portion of your 2021 dues is 91%.

Tax Deductibility on Friend of the OSBF Donations. The Ohio State Bar Foundation (OSBF) is a qualified charitable organization under 501(c)(3) of the Internal Revenue Code. As such, your donation to become a Friend of the OSBF is 100% tax deductible.

Ohio LAW PAC (Political Action Committee). Contributions are discretionary and in addition to your dues. By law, only contributions from individuals, partnerships, LPAs, LLCs and LLPs should be remitted. Corporations, not-for-profit corporations and labor unions may not make contributions to political action committees. Members of such entities may contribute on their own. Contributions to LAW PAC are not deductible for a federal income tax purpose.

Complimentary CLE and OnDemand Passes. All OnDemand CLE Passes and complimentary CLE courses included as part of a membership plan expire on Dec. 31 of that membership year. Courses reserved using the OnDemand CLE Pass or through complimentary membership plan offerings apply to self-study only and must be completed in the year in which they are selected. All self-study CLE courses expire on the last day of the calendar year in which they were approved by the Supreme Court of Ohio.
